(b) The treasurer shall be responsible for the issue of receipts vouchers for funds received or paid out by the trust.

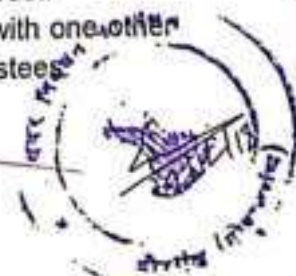
